Monitoring Compliance

- Transition Support (e.g. TDY, PCS, elementary to middle to high school)

- Homeschool Support (e.g. laws and policy, support groups, testing, SPED)
- PreK-12 Education Options (e.g. School Choice, Attendance and Boundaries, laws and policies)
- College, Career and Military Readiness (e.g. JROTC, STEM, STARBASE, Cyber Patriot, mentor, adopt-a-school, career day, internships)

Too often, I have seen or heard of military members struggling with a school issue, but had not contacted their SLO. Many times, when they did, the problem was resolved. This is why it is important for commanders to ensure the SLOs are well known throughout the installation."
